1] **Apologies** There were none.

2] **Declarations of Interest** There were none.

3] **Minutes from previous meeting held on November 2, 2010**, were accepted as circulated and signed by the chairman after it was pointed out the name Finch in the clerk's report should have said French and it should have referred to the notice board at the village hall.

4] **Clerk's report** There was nothing to report.

5] **Correspondence**

E.on wrote to confirm the arrangements for the unmetered electricity supply for the red telephone kiosk in the centre of Wysall. Coun. Philip Harris had written asking for Bowling Club Trustees to be appointed to replace Mr Leslie Derrick and Mr David Onions and it was agreed that Coun. Roberts be appointed with a view to looking to see if a further appointment could be made from a resident in the village.

Rushcliffe Borough Council and Rural Community Action Nottinghamshire advised of a Parish Council Forum event on 'Elections' on Monday February 7, 2011, at the Civic Centre, West Bridgford. Couns. Mrs Charlotte James and Mrs Mary Elston would attend.

Rushcliffe Borough Council wrote asking for details of all play areas and open spaces in the parish for the audit report of 2010. The clerk was asked to complete the form. Willoughby on the Wolds Parish Council advised of its support for any action in regard to dealing with the problem of slow speeds of broadband in the local parishes. The clerk was asked to contact Hickling Parish Council where a scheme, it was understood, was in operation and to make it an agenda item for the next meeting.

Rushcliffe Borough Council advised of the precept requirement arrangements for 2011/2012.

Nottinghamshire County Council confirmed the making of the Keyworth Bridleway No 5 / Widmerpool Bridleway No 9 / Wysall Bridleway No 7 Modification Order 2010. It was understood there might be an appeal against the County Council decision.

6] **Planning matters**

Notice of Proposed Works to Trees

10/00181/CONARE Mr and Mrs Noble; Fell Cherry, Maple and Lime and prune back Cherry overhanging garage; The Manor House, 2 Main Street, Wysall. Rushcliffe Borough Council did not propose to make a Tree Preservation Order and work had been allowed to proceed.

10/00202/FUL Mr MacSweeney; Fell Horse Chestnut and Sycamore; Wess's Barn, Widmerpool Road, Wysall. Rushcliffe Borough Council did not propose to make a Tree Preservation Order and work had been allowed to proceed.

7] **Village Hall**

The clerk reported that Coun. Mrs Fiona Mason had confirmed she would be happy to make a grant towards the cost of new tables that had been purchased. Coun. Mrs Elston reported the Christmas fair had raised £940 for hall funds. In addition a local couple had donated £18.70 in one and two penny coins they had saved over a period of time.

There had been continuing complaints in regard to heating problems and the chairman said he would talk to Mr Berridge to ascertain if he was going to provide the new units requested. He would also be asked to replace taps in the toilets that turned the opposite way to normal. There was also a need to attend to the heating units in the kitchen as they were also not working.

There was to be another Village Ventures show in the hall on April 15, 2011.

8] **Environment**

The clerk was asked to confirm a visit from Notts County Council aimed at seeking comment from the council on problem items in the parish that needed attending to. The clerk had delivered two bags of salt on the evening of the meeting.

9] **Dog Fouling** There had been no progress on this item.

10] **Website**

The number of hits on the site in November had been a record figure of 2122 with a total of 889 unique hits.

11] **Finance** Members authorised payment of accounts as per the schedule presented.
