81 VILLAGE HALL

Coun. Grenz reported on the recent meeting of the hall committee. He said the closure of the NatWest Bank at Keyworth was not causing too many problems and the Post Office there was being used for cash transactions.

He said discussions had taken place on future fund raising events in the hall and these included three film shows, In October, January and March. Other events included a performance from the Village Ventures organisation, a wine tasting event, a cookery display and the Christmas Fair on November 28. The food fair planned for September 20 had 30 stalls booked in. Other possible events were a quiz evening, a Halloween event and a jazz night.

He said the committee currently had £2152 in the bank.

9] ENVIRONMENTAL MATTERS

The chairman raised the question whether or not the village should have a defibrillator. He said if there was one it could be sited in the village telephone box. He did not think it should be a matter for the parish council to supply a unit but he felt sure members would support the idea if the village itself wished to establish a group to undertake the project. Members agreed with the chairman. It was suggested the cost for a unit could be up to £3000.

No action was proposed in regard a suggestion BT should be asked to return to properly reinstate excavated land in front of the Village Hall. The advice was that the area would return to its former state naturally if left alone.

The clerk was asked to contact Notts County Council to get their approval for a village working party to refurbish the two wooden finger direction posts in the village.

10] FINANCE

11] VILLAGE WEBSITE

The meeting agreed that Coun. Stanley pursue necessary work in connection with the village website. There was comment that some items were very dated and needed removing.
